The Barnes County Commission met in regular session on Tuesday, June 4, 2024, with Vicky Lovell, Bill Carlblom, Pete Paulson, and Shawn Olauson present. Cindy Schwehr was absent. Chairman Carlblom called the meeting to order at 8:00 a.m., roll-call was taken, the Pledge of Allegiance was recited, and the agenda was reviewed.

US FISH & WILDLIFE SERVICE

US Fish & Wildlife Service is requesting approval to purchase SE 1/4 of Section 33-138-59 from John and Helen Olson. Shawn Olauson moved to approve the land purchase by US Fish & Wildlife Service; Pete Paulson seconded the motion. Motion carried unanimously upon roll call vote of all present members.

Weed Board

Jamen Windish did not find any grants available for infrastructure to help with the cost of a new building. Jamen will continue to look for lower cost options. The new employee is working out well and Harley is back for the summer.

Corrections

Anna Berntson requested approval to attend along with Sgt. Soderholm and Sgt. Coit, the IACTO 40th Annual Conference being held in Bismarck September 16th through September 19th, 2024 at a cost of \$2,211.70 for three employees. Bill Carlblom moved to approve the three Correction Officers to attend the conference; Shawn Olauson seconded the motion. Motion carried upon roll call vote with all present members voting yes. Trail County Inmate Boarding contract was signed.

<u>Auditor – Minutes</u> Vicky Lovell moved to approve the May 21, 2024 minutes; Shawn Olauson seconded the motion. Motion carried with all members voting yes. Jared Lentz has turned in his resignation leaving the HR/Payroll position open, and the position is being advertised. Julie has 82 vacation hours to use or lose by June 30th. The commission members agreed to allow Julie to carryover 82 hours of vacation to use as soon as possible. Shawn Olauson will give the financial request from the Red River Basin Commission to the Water Board for consideration. Perry Schlagel submitted an application for the open board member position on the BCWRD board. Shawn Olauson made a motion to approve Perry Schlagel as the new member of the BCWRD board; Vicky Lovel seconded the motion. Motion carried upon roll call vote. Shawn will notify Perry of the board acceptance.

Commission Discussion

Commission discussion included portfolio updates. Pete provided an update on VSO activities. Tammy is in the process of interviewing for an Office Assistant. If the applicant has good qualifications, Tammy can offer the applicant \$22.00 per hour. They are still looking for a part-time driver. Vicky Lovell still has tickets available for the library foundation fundraiser. Shingling for the library roof is scheduled to begin June 20th. Jamie Smith notified the commission that on May 22nd, the Sheyenne River Water Trail had surveyed, bid & located for the installation of signs along and in our county right of way. Anchors and other devices have been installed and some signs as well as sign assemblies. It is upsetting and disturbing and disappointing that the Barnes County Highway Department was never contacted regarding this signage project, especially of this magnitude. Upon receiving a review of the plan set, it was discovered that there are 67 signs to be installed in our county right of way and on county owned bridges. The signage does not meet our standards and does not follow county sign policy which was adopted in 2015. If these signs stay in our right of way and we are required to maintain them, it will be at a cost to the county. Encouraged by Commissioner Carlblom, Jamie has reached out to Bobby Koepplin and informed him that the signage was not approved through the Highway Department and will not be allowed without authorization from the county Highway Department and the commission. It is requested that because specifications were not considered and approval from the Highway Department was not granted and additional costs to the Highway Department will be incurred, that authorization be given to the Highway Department to remove the unauthorized signs at a cost to the Sheyenne River Water Trail. Commissioner Carlblom was aware of a couple of signs going up but not a sign project of this magnitude. Jamie testified on a Spring Road Restriction hearing this morning which went well. The Highway crew is working on graveling projects. Stacie Hansen, Director of Equalization, provided the commissioners with a pre-Equalization meeting information guideline. Preliminary numbers going into Equalization were handed out.

Bill Carlblom moved to recess the meeting until 1:00 PM; Shawn Olauson seconded the motion. The meeting recessed at 8:55 AM.
