Emergency Management

Jessica Jenrich requested permission to hold a de-escalation and personal safety training through CISA and would like to make it mandatory for courthouse employees. This would be on November 20th with two sessions so that offices will not need to be closed. The commission agreed that is should be mandatory for courthouse staff to attend.

Auditor's Office

Vicky Lovell moved to approve the August 20th, 2024 minutes. Pete Paulson seconded the motion. Motion carried upon roll call vote with all members voting "yes". Application process for filling the payroll position is still open.

Commission Discussion

Pete Paulson reported that another part-time van driver was hired for the Veteran Service Office. Shawn Olauson has meetings next week. Cindy Schwehr discussed the school nurse situation. The school would like to have the nurse present at the school a little longer during the day than what they are presently scheduled for. The school pays a set amount for the nurses, but it doesn't cover the full schedule of the nurse's hours. City County Health nurses are working 32 hours with full time benefits, so it does save a few dollars off the budget. Vicky Lovell reported that HUD had to evict a resident, and they will have a current resident monitor the facility at night and they will pay a stipend to that resident. Bill Carlblom reported that the restructuring of offices in the courthouse has a slight change. The Sheriff's Office will occupy all the northwest corner of the first floor in the courthouse where Eligibility currently has their offices. They may need to do some construction within the office space. Emergency Management – Planning & Zoning will be moving up to third floor. No opposition was expressed by the commissioners regarding the restructuring of the office spaces to this plan. One more office is needed to get the remaining county office that is renting space back into the courthouse. The Winter Show had a horse show last weekend, and the derby will be coming up this weekend.

A mandatory department head meeting was held with each department head updating the commissioners of what is happening in their office and to express any concerns that anyone may have. Jeremy Wolff - Corrections, Jamie Smith – Highway, Debbie Magnuson – Treasurer's Office, Alisha Harstad – Extension, Sarah Miller – Dispatch,

Jessica Jenrich – Planning & Zoning/Emergency Management, Pat Sand – Sheriff's Office; Scott Kohler – Parks, Jason Thiel – IT, Jody Pfaff – Recorder, Jamen Windish – Weed, Chris Iverson & Wanda Auka – ND Courts, Stacie Hansen – Tax Equalization, Shane Kalbrener – Environmental Services, Kerry Due – CCHD, Julie Mindt – Auditor's Office, and Tonya Duffy were present. The commissioners requested a courtesy notice when a department head goes on vacation and update them on any thing going on that may be of concern or interest to them. If the public brings a topic to them, they would like to know what is being done through out various offices so that they can pass that on to the general public when they get questions.
