

January 2023 Tech Report

Trees/Weed Barrier:

- Have 17,450 trees on order for spring- (9,275-Big Sioux, 7,550-Towner, 625-LO)
- Currently have 99,510ft of trees planned for 2023. That is up from 55,885 last year. (43,625ft increase) 22 sites.
- I will stop taking machine plantings for 2023 when we reach 105k foot or February 15, whichever comes first.
- We had 60 rolls of weed barrier in stock after last year. I purchased another 170 rolls from NYP Corp. on 12/29/2022. The price quoted was \$93.00/roll down from \$97.00/roll last year.
- Total cost of W/B for 2023 is \$16,710. Payment terms cash in advance. To be delivered in April.
