## Trees:

- All 2022 OHF contracts are signed and sent off
- Currently have 16 tree sites to plant in the spring of 2022. Totaling over 67,000ft of shelterbelts.
- There has been a lot of trouble with other districts ordering from Lincoln Oaks.
   Prior to these issues I cancelled most of my tree from LO and ordered from Big
   Sioux per our meeting discussion.
- Current tree orders-
  - Big Sioux-6,300 trees (45%)
  - Towner-6,100 trees (44%)
  - Lincoln Oaks-1,475 trees (11%)

# OHF Grant Proposal:

- Cass initially got a 2yr county OHF grant that went extremely well. Ran out in 2020
- They reapplied in 2021 and Industrial Commission declined it.
- Eric Dahl said it was a great success and after OHF declined the 2<sup>nd</sup> round Cass County SCD chose to totally fund their own grant.

Barnes County has 2 different EQIP Applications for FY 2022. Cover crops, no-till, and livestock watering systems.

We have 4 WRE applications that were submitted.

Cody, Alex and Shawn are working to complete CRP expiring reviews and send out the review forms (over 100). This process is about completed and we are starting to receive some of the forms back for FSA.

Barnes County NRCS was supposed to receive a summer intern (Pathways Student), the student decided not to proceed. So we will not be getting a summer intern.

Barnes County NRCS has an opening for a new employee. This position would specialize more in the business tools (computer programs we use).

The NRCS as a nation is now going to post a completely new position. This is an Outreach position with 1 in each state potentially. ND will also be continuing with this.
