

NRCS Activity Report Barnes County Soil Conservation District Board

April 14th, 2021 Shelby Larson, Acting District Conservationist (DC)

I have about two and a half weeks left in Barnes County. I believe my last day is the 30th. I'm hoping to leave the contracts a little more cleaned up and ready to roll for 2021. I've been working with producers to get them ready for the practices they have scheduled and hope this helps things run more smoothly.

As of now the Valley City DC job has not been reopened. Therefor, there is not an idea on when someone new will be filling in permenantly.

I submitted 2 EQIP applications up to the state for review of ranking and funding available. We will hopefully hear by the end of this week if either application will get funded.

Barnes County has 1 person interested in renewing their CSP Contract. He has signed the application and came in and talked about different options. However, CSP has changed it's guidelines and the process of getting into CSP more than once is becoming quite complex. We will continue working with him and see what we can come up with.

Two producers have signed up for the general CSP. Alex and I will be working with them to get them to meet eligibility and move forward with planning different practices to meet their operations goals.

Cody submitted 6 different WRE's up to the state office for review of ranking for Barnes County. Roughly 4-10 Waterbank applications will be due on May 7th. This varies because it will depend on who wants to continue with their application.

<u>Covid Update:</u> No board meetings in the office. Masks are require by all employees to wear full time when in the office. The NRCS/SCD is allowed to have 4 employees in the building and FSA is allowed to have 4 employees in the building at a time. Others are encourage to work at home. The offices are to set up rotations. The doors are closed to producers, but we are accepting appointments and letting farmers in then. We are allowed to do field work and have Box/OneSpan to utilize.

Technician Report Mar/April 2021

Trees:

- Currently have roughly 80,000ft of trees contracted on 20 sites for Spring 2021.
- Have substantial tree orders from 3 nurseries (LO, Towner, Big Sioux)
 planning pickup last week of April.
- Hoping to start planting week of May 10th.
- Listed job openings for seasonal laborers and received 6 applicants.
- After interviews hired 2 VCSU students (Easton Hesch, Avery Bennefeld) to work as laborers and hired Paul Metcalf to drive tractor this year.

Equipment

- Sold our Marshall tree saw on Wednesday March 24th to Roger Christianson (Plaza, ND) for \$7,250.
- Will need to install new tires on trailer soon. Would prefer to update trailer due to being undersized and overweight with our equipment.
- Got several quotes and looked at several models (ABU, LoadTrail, Midsota) and took measurements to make sure they would fit our needs.
- Vistos Midsota 22' trailer was the best built and dimensions were exactly what we need. Its 2 ft longer, capable of 2,000lbs more payload and 6inches lower than out current trailer. Quote is \$6,795.00.
- o Trade in on our trailer is poor but was advised to sell ourselves. Value of our trailer is still in the \$3,000-\$3,500 range. Trade in was \$2,100.
- o Installed Timbren Rear suspension assists in our 2010 1 ton Silverado to help with weight problem on rear of truck.
