The Barnes County Commission met in regular session on Tuesday, May 2, 2017 with Cindy Schwehr, Bill Carlblom, Mike Metcalf, John Froelich, and Rodger Berntson present. Chairman Metcalf called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

Keith Colville – Trespassing Issue

Ms. Neuberger will continue to monitor both machines to make sure that they are in working order.
