Cindy Schwehr moved to re-appoint Tom Overn to the City County Health District board for another term; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Emergency Management - Mutual Aid Agreements

Sue Lloyd, Emergency Manager, presented mutual aid agreements with South Central Adult Services, Dietrich & Sons, City of Valley City, Stutsman County, Ransom County, Steele County, and Cass County. Cindy Schwehr moved to enter into mutual aid agreements with the entities listed; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". 911 addressing has now been sent to the State for their review and updating.

Commission Discussion

Legislative changes regarding Social Services funding will cost the County more money. The lost taxpayer savings due to the repeal of the 12% state-paid discount will not be fully made up by the Social Services costs being reimbursed by the State. John Froelich made a motion that, in the event that the Commission approves a Snagging & Clearing project, the County Commission has the option to pay their share out of the General Fund, rather than setting up an assessment district; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Cindy Schwehr moved to approve an estimate from Pro-Lot Maintenance for sweeping and re-striping the parking lot; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Estimates have been requested for sidewalk replacement. Cindy Schwehr moved to allow Al Berg from Premier Benefits to review County insurance options; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". John Froelich provided an update on water issues, Silver Creek Drain, Devils Lake Outlet, and Hobart Lake Outlet.

With no further business, Bill Carlblom made a motion, seconded by John Froelich, to adjourn the meeting. Motion carried unanimously, and the meeting adjourned at 9:33 a.m.
