

The Barnes County Commission met in regular session on Tuesday, June 6, 2017 with Cindy Schwehr, Bill Carlblom, Mike Metcalf, John Froelich, and Rodger Berntson present. Chairman Metcalf called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

**State's Attorney – City of Valley City Truck Regulatory Agreement**

Carl Martineck, State's Attorney, and Randy McClafin, Sheriff, presented a draft Joint Powers Agreement and Resolution for Truck Regulatory activities within Valley City city limits. Cindy Schwehr moved to approve the Agreement and Resolution; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". This will be in effect once the city signs it.

**Tax Equalization – County Equalization Updates**

Stacie Leier, Tax Director, briefed the Commission on the upcoming equalization proceedings.

**Highway Department – Final Project Verification**

Kerry Johnson, Highway Superintendent, introduced new employee Heather Manson. Mr. Johnson provided a project update and requested signatures for the Final Project Verification stating that the money came from the local farm-to-market fund for the microsurface job last year.

**Auditor – Minutes**

Cindy Schwehr moved to approve the May 16, 2017 minutes with corrections; Bill Carlblom seconded the motion. Motion carried.

**Auditor – Special Event Permits**

Beth Didier, Auditor, presented an Application for Special Permit to Sell Alcoholic Beverages at a Special Event at Designated Premises from Boomer's Corner Keg for the Dakota Riders Hill Climb on June 18, 2017. Cindy Schwehr moved to approve the application; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Ms. Didier presented an Application for Special Permit to Sell Alcoholic Beverages at a Special Event at Designated Premises from Tavern 94 for a private wedding reception in Ashtabula Township on June 18, 2017. Cindy Schwehr moved to approve the application; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

**Auditor – Gaming Site Authorization**

Ms. Didier presented a Gaming Site Authorization request from the Frank S Henry VFW Post 2764 for a pull tab dispensing device at Ashtabula Crossing. John Froelich moved to approve the request; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

**Auditor – Local Permit (Raffle)**

Ms. Didier presented an Application for Local Permit from Waldheim Lutheran Church WELCA for a raffle. Bill Carlblom moved to approve the application; Rodger Berntson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Cindy Schwehr moved to recess for lunch; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".
