- ➤ 8 OHF contracts funded so far for 2025 totaling 43,900ft. Will need to get contracting completed and mailed back
- ➤ 4 contracts submitted after July 15th yet to receive funding. Waiting on Cultural Resources Inventory by SHPO. (27,115ft)
- ➤ I will be submitting our initial tree orders to Big Sioux and Towner nurseries this week.

Drill/Grass Seeding

- > All grass seedings around 2024 tree plantings completed.
- ➤ August CRP seeding window Aug 10-25th sites completed.
- ➤ 1590 continues to be routed around county. It generally slows down now until dormant seeding later this fall. Dormant seedings require 5 consecutive days below 45deg ground temp.

Other

- > Sealed shed to prevent any more rodents.
- ➤ Compressor quote for cooler from Bakkegard and Shell for \$4,490.00. Tree Planting Initiative (NDASCD) did not receive funding. Compressor will need to be paid for by SCD.
- Continue to spend one day a week at the parking mowing and general upkeep.
