

- 2. There was discussion on all of our accounts at Wells Fargo. Since we now have our loan and certificate of deposit at Dacotah Bank, Nelson made a motion to close all of our accounts at Wells Fargo and move them to Dacotah Bank.

  Bruns second the motion, all in favor aye, motion carried. Jill will get in touch with Dacotah Bank and Wells Fargo to get this process started.
