Sheriff – Sheriff Pay Scale

Randy McClafin, Sheriff, requested a pay raise of \$3.50 per hour for himself to bring him to the same level as the Valley City Police Chief. No action was taken, as the consensus was to address further salary increases in the upcoming 2017 budget discussion.

Auditor – Minutes/Miscellaneous

Cindy Schwehr moved to approve the November 17, 2015 minutes with corrections; Bill Carlbom seconded the motion. Motion carried.

Board Appointments

The following incumbent board appointments were proposed: Steve Nielson - 5 year term on the Airport Authority; Scott Tichy - 3 year term on the County Park Board; Deb Kohler - 3 year term on the Senior Citizens Council; Theresa Will - 2 year term on the South Central Human Service Advisory Board; Bruce Anderson - 3 year term on the Water Resource Board for District 4; and Dave Vareberg - 4 year term on the Weed Control Board. Cindy Schwehr moved to approve the appointments, as presented; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Bill Carlblom moved to appoint Henrik Voldal to a 3 year term on the School Annexation, Reorganization, and Dissolution Committee; Rodger Berntson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". An opening remains on the Senior Citizens Council. Cindy Schwehr made a motion to eliminate the requirement for applications for incumbents; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Wellness Committee

Sue Milender-Toppen, Kerry Johnson, and Randy McClafin appeared on behalf of the Wellness Committee, and shared information regarding the upcoming Leap into a New Year walking challenge and the Barnes County On the Move program.

Highway Department – Bid Awards

Kerry Johnson, County Road Superintendent, and Shawn Mayfield, Kadrmas, Lee & Jackson, presented the following Resolution 2015-7 for the bid award for a micro-surface project on County #7 from Eckelson south to ND #46 :

WHEREAS, the bid in the amount of \$1,195,634.36 from Asphalt Surface Technologies Corporation received in the bid opening of November 13, 2015 for Project SC-0207(059) was the low bid received. WHEREAS, this bid is considered reasonable, NOW THEREFORE, be it resolved by the Board of County Commissioners of BARNES County will award to Asphalt Surface Technologies Corporation the contract for Project SC-0207(059) and hereby authorizes the Chairman of the Board to sign said contract. It is further understood that the County shall reimburse the North Dakota Department of Transportation for any payments made under this contract, which are not collectible from the Federal Highway Administration.

Cindy Schwehr moved to approve the Resolution; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Cindy Schwehr moved to award the 2016 paving projects to Knife River Materials at a total cost of \$3,476,481.90; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". This includes CR#22 Stutsman line to Eckelson, CR#22 ND#1 to I-94, and CR#27 I-94 north 14 miles, as well as Clausen Springs Park and Little Yellowstone Park. No county match is required on the three County paving projects. There is a 20% county match on the micro-surface. The State Special Road Funding for the park projects is a 40% local match.

Appointment of Emergency Manager

Bill Carlblom moved to appoint Sue Lloyd as Emergency Manager, effective January 1, 2016; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Her rate of pay will be \$21.34 per hour.

Appointment of Veterans Service Officer

Bill Carlblom moved to appoint Angela Hunt as the new Veterans Service Officer, pending passing of the background check, possibly starting December 7, 2015; Rodger Berntson seconded the motion. Motion carried upon roll-call vote, with all members voting "yes". Her rate of pay will be \$20.09 per hour to start, with an increase of \$1.25 effective January 2, 2016.

Interstate Engineering – Introduction

Darren Peterka and Mike May from Interstate Engineering introduced themselves to the Commission, and informed them that they now have a local office.

Commission Discussion

John Froelich will research the possibility of getting a rider through Insurance Reserve for additional coverage for employees transporting clients in their privately-owned vehicles. There is another meeting on December 3rd at 4 p.m. to discuss the culvert repair at a property on West Main Street. Appreciation was expressed for the donation of 25 pounds of burger from Leever's for the chili feed for County employees last week. The Commission visited with Recorder Jody Pfaff to confirm that the information received in the Recorder's Office is public information.
