

The Barnes County Commission met in regular session on Tuesday, December 5, 2017 with Cindy Schwehr, Bill Carlblom, Mike Metcalf, John Froelich, and Rodger Berntson present. Chairman Metcalf called the meeting to order at 8:00 a.m., the Pledge of Allegiance was recited, and the Agenda was reviewed.

Reorganization

Mike Metcalf nominated Bill Carlblom to serve as Chairman and Cindy Schwehr to serve as Vice-Chairman; John Froelich seconded the nomination. Mike Metcalf moved that nominations cease and that a unanimous ballot be cast; John Froelich seconded the motion. Motion carried, with all members voting "yes". Bill Carlblom took control of the meeting as Chairman.

Griggs County Emergency Manager

Griggs County contacted Mike Metcalf, asking if we would be interested in contracting with them for Emergency Management services (sharing Sue Lloyd with them). The general consensus of the Commission was that we are not interested in sharing at this time.

Dispatch – Emergency Message System

Sue Lloyd, Emergency Manager / Dispatch Coordinator, presented a request to contract with Everbridge to replace CodeRed. The CodeRed contract ends today. The initial cost is \$6,750 to get started, and then \$2,500 per year thereafter. The cost of training (\$8,000) will be split between Barnes, Stutsman, and Richland Counties. Code Red is currently \$5,000 a year and is limited in its capabilities. Mike Metcalf moved to switch from CodeRed to Everbridge; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Auditor – Minutes / Court Facilities Improvement Grant

Cindy Schwehr moved to approve the November 21, 2017 minutes; Mike Metcalf seconded the motion. Motion carried. Beth Didier, Auditor, presented a Court Facilities Improvement Grant application for repair and painting of 3rd floor rotunda plaster, requesting \$6,000 in Grant funds. John Froelich moved to approve submitting the application, with a County Cost Share of \$2,000; Mike Metcalf seconded the motion. Motion carried upon roll-call vote, with all members voting "yes".

Commission Discussion

Discussion included a bounced check on a redeemed tax sale property, South Central Dakota Regional Council, Barnes County Museum. The Commission would like minutes submitted from all boards that receive County monies. Dreis' Bridge repair is progressing nicely. Also discussed was: Hobart Lake project, County burial options, 911 radio options, truck regulatory, board appointments & liquor licenses at the next meeting, County Christmas party, and tax statements.
