Barnes County Auditor Beth Didier called the meeting to order at 8:00 a.m., and the Pledge of Allegiance was recited.

Relay for Life

Rad Nicholson, Barnes County Relay for Life chairman, requested use of the Courthouse grounds on June 16, 2017 for the annual Barnes County Relay for Life event. Cindy Schwehr moved to approve the request; Bill Carlbom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Planning & Zoning – 2017 Development Code Changes

Jessica Jenrich, Planning & Zoning Coordinator, presented updates to the 2017 Development Code. Rodger Berntson moved to approve the changes as presented; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Auditor – Minutes / EAP Contract Renewal / Board Appointment

Bill Carlblom moved to approve the November 15, 2016 minutes; Rodger Berntson seconded the motion. Motion carried. John Froelich moved to approve renewal of the contract with The Village for Employee Assistance Program services; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Cindy Schwehr moved to approve appointment of Shawn Olauson to the School Annexation, Reorganization, and Dissolution Committee; John Froelich seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Social Services – Approval of On-Call Time / Director 6 Month Review / Tire Replacement

Wanda Larson, Social Services Director, requested approval to pay a soon-to-be former employee for one hour’s time, at her current salary, for seven days in November (one hour each day) for on-call services. Cindy Schwehr moved to approve the request; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Tom Overn, Social Services board president, stated that Wanda Larson’s job performance as Director is satisfactory and recommended that she graduate from trial-period status. John Froelich moved to approve the recommendation; Cindy Schwehr seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Rodger Berntson moved to approve purchase of tires for the van and the car; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Highway Department – Construction & Maintenance Agreement

Kerry Johnson, Highway Superintendent, presented a Construction and Maintenance Agreement for the Faust Dam project for approval. Cindy Schwehr moved to approve the request; Rodger Berntson seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”.

Sheriff – On-Call Time

Randy McClafin, Sheriff, and Jed Reile, Deputy, presented a proposed on-call policy for the Sheriff’s department. John Froelich moved to rescind all on-call pay policies; motion died for lack of a second. Discussion was tabled until the second meeting in January.

VC-BC Development Corp – SCDRC / Annual Agreements

Jennifer Feist, Director of Development for the Valley City – Barnes County Development Corporation, and Brenda Moritz, SCDRC Interim Director, requested approval of \$19,328 for 2017 membership in the South Central Dakota Regional Council, as well as the South Central Dakota Regional Council Joint Exercise Governmental Power Agreement. John Froelich moved to approve the request; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Ms. Feist requested approval of the 2017 contract with the Valley City – Barnes County Development Corporation for the calendar year January 1, 2017 through December 31, 2017. The contract includes 2.04 mills as budgeted and \$27,000 for administrative services. Cindy Schwehr moved to approve the request; John Froelich seconded the motion. Motion carried upon roll-call vote, with Rodger Berntson voting “no”.

Valley City Rescue Squad – Pump Update

Scott Magnuson, Valley City Rescue Squad, expressed thank you for the new pumps on the rescue truck and updated the Commission on the pumps, as well as grain bin extrication.

Vote-By-Mail

The 2016 Primary and General Elections were administered using Vote-By-Mail, with one in-person voting location at the Barnes County Courthouse rotunda. The Commission discussed pros and cons of continuing to administer the elections in this manner.

Commission Discussion

John Froelich moved to designate the play/visitation room as the designated breastfeeding room; Bill Carlblom seconded the motion. Motion carried upon roll-call vote, with all members voting “yes”. Federal overtime rule changes were discussed, and the commission decided that no changes to the budgeted salaries for 2017 need to be made. The Courthouse will be closed at noon on Friday, December 23, 2016 for the Christmas Eve holiday, and will be a closed on Monday, December 26, 2016 for the Christmas holiday. Weed spraying on County property was discussed. Storm policy was discussed.
