

Minutes of Meeting February 12, 2025 USDA Building Valley City, ND 58072

Financials:

EQIP Batching deadline was September 20th, 16 applications. We still accept applications all year round. The applications will be ranked in January and find out if they are funded then

Currently no applications were funded. IRA money has been put on hold. This is a large amount
of our EQIP funding

WRE IRA money is also put on hold. We have been told to rerank our WRE applications for general funding. Cody has been busy working on these.

SE Area will be having monthly in person meetings in Jamestown. Our last meeting was January 15th, Cody, Alex, and I attended.

All government agencies are in a hiring freeze. Both applicants that were going to be stationed in the Valley City office have been rejected due to the freeze.

Sandy, our wetlands clerk has been released of her duties as of now. Sandy is a contacted employee through Clear Global. We should hear more about this by the end of March.

Deferred Resignation Program (Fork in the Road) has been offered to government employees. This resignation opportunity is currently still open for people to utilize.

EQIP MBRI deadline was February 7th. Ranking is due February 14th. 3 applications, currently trying to complete 2 that came in late on the 7th.

February 2025 District Technician Report

Trees:

- > 17 tree plans currently finalized. Roughly 75,000ft. Up from 55,000ft last year.
- ➤ Will take machine plantings until Feb. 15-Nursery stock selling out limiting planning.
- > Will continue to take hand plant orders as long as I call fill them.
- > OHF Funding is still questionable for 2026
- > I have roughly 17,000 trees ordered so far from 3 different nurseries.

Other:
