
New Business:

Cody and I attended SE Zone meeting in Jamestown on May 28th

Waterbank- we have 13 applications. 8 of these are considered high priority. Cody and I have been working on planning these.

Another one of my 12 EQIP applicants has been selected for funding. 2 were preapproved in Barnes County, 1 high tunnel and 1 MBRI

All 4 CSP applications were selected for funding in Barnes County, 21 total across the state were preapproved. I have completed all the paperwork and planning for these contracts

WRE/WRP onsite monitoring's are happening currently, I will be doing the majority of these with Cody helping on some

CRP signup has opened and closed. This is a large signup in Barnes County- Cody has been very busy with CRP site visits and planning

Trees:

- May 12th-planted 1st site. May 19th started planting again after weather delays with seasonal help.
- > June 2nd-Finished planting trees and switched to weed barrier.
- > June 6th-Tree surplus sale.
- ➤ I have Jessica taking orders for any remaining bundles. Will continue until June 13th then cooler will be shut down.
- > Should finish weed barrier in the next week then switch to grass seedings.

Pickup discussion:

- > Picked up new pickup in Bismarck May 15th
- May 21st /22nd had topper installed in Moorhead and installed airbags at shed. Started using new truck almost immediately.
- ➤ Bidding for both trucks ended June 1. Sold ½ ton for \$12,000 (trade in was \$7,500) to Lil Borg after multiple people bid on it. One ton is available for purchase (trade in was \$15,000).
